Site Licenses

A license is issued to an organization, typically defined by a specific mailing address. There are no limits on the number of users/developers, the number of application systems and environments (i. e. FUSER files), nor the number of CPUs being supported by a single **ZZUtils** license at that location, so long as all applications and environments are owned by the licensee.

Site licenses are available to commercial data centers, government operations which support multiple agencies, and distributed organizations with multiple development centers. Contact LEN CONSULTING LLC for more information.

Payment
